LIXI 2.0 - Member Engagement Session

LIXI 2.0 is a strategically important initiative and implementation of this next generation of lending industry standards is imminent. As LIXI focuses on its core value and reestablishes itself as the custodian of Australian data messaging standards, it will be important to keep up to date with upcoming changes. This information and Member engagement session will address the future of standards within the context of LIXI 2.0 and cover the following key elements of this initiative:

- Comprehensive new data standards Based on the LIXI 2.0 Data Dictionary, which unambiguously defines all the data used within the standards and provides the structure for the CAL 2 schemas and business rules.
- **New licensing and pricing agreements** Licensing changes, developed in consultation with the industry, anchor the value of the standards and include fair and equitable pricing.
- Change management For use with the Data Dictionary, this new process will ensure changes are completed in a timely manner with associated SLAs.
- **Conformance testing** A new testing regime will ensure that messages conform to the new standards, reducing resource requirements and increasing certainly.
